Business Hours: Friday 10am-5pm, Saturday 10am-10pm and Sunday 10am-5pm

Set Up/Tear Down: All guilds will be set up and ready for the scheduled gate opening, (10:00 am) Friday morning. Guilds will be allowed onto the grounds starting 8:00 am Thursday. All participants are to vacate the park grounds by 12:00 noon Monday. All modern tents set up on site will be in tent city. All vehicles are to be removed from field to participant parking areas.

Site Fees: \$15.00 per person for all overnight campers. RV or Tent.

Showers: There are showers. Bring your own towels, and toiletries.

Water/Electricity: Potable water and Electricity is available in camp.

NO Cell Phones: In order to maintain the proper atmosphere and create the best experience possible for all, cell phones must be out of sight and earshot during show hours.

Animals: No pets, only hired animal acts and service animals allowed.

Alcohol/Controlled Substances: The sale of alcoholic beverages is strictly licensed and controlled. Alcoholic beverages will only be available at the Pub. Under no circumstances are any controlled substances allowed on the festival site. Anyone with controlled substances in their possession on the show site is subject to immediate expulsion

Structures/Participant Costumes: Participants must provide their own tents, tables, chairs, food, drinks, lights, etc. Participants shall be in garb and should at all times strive to emulate the speech and mannerisms of the people they are portraying during hours of operation. All modern tents will be placed in tent city, no modern tents on faire site.

Weapons: All weapons must be sheathed or holstered at all times. Any person found brandishing a weapon other than for a scheduled performance or re-enactment will be subject to immediate expulsion. All vendors selling weapons must provide string or ribbon for peace-tying and will advise customers to keep all weapons peace-tied.

Security: Security will be provided for event. Notwithstanding, this is not meant as a guarantee. T.R.E. The Yuma County Fairgrounds, their sponsors, officers, employees, and agents are not responsible for any loss, theft, damage or injury to any person or property.

Decency: T.R.E. will not allow behavior that offends community standards T.R.E. has final say as to the appropriateness of all skits, garb, and performance.

Indemnification: All participants agree to indemnify, defend and hold harmless, T.R.E., The City of Yuma, The Yuma County Fairgrounds, and any of their sponsors, officers, employees, and agents from any loss, theft, damage or injury to any person or property during the event.
